THE GRAND JURY CHARGES:

COUNT 1 21 U.S.C. § 841(a)(1)

On or about May 16, 2023, in Scott County, in the Eastern District of Kentucky,

JAMELE WYDALE MUNDY

did knowingly and intentionally possess with intent to distribute 400 grams or more of a mixture or substance containing a detectable amount of fentanyl, a Schedule II controlled substance, all in violation of 21 U.S.C. § 841(a)(1).

COUNT 2 21 U.S.C. § 841(a)(1)

On or about May 16, 2023, in Scott County, in the Eastern District of Kentucky,

JAMELE WYDALE MUNDY

did knowingly and intentionally possess with intent to distribute 28 grams or more of a

mixture or substance containing a detectable amount of cocaine base, a Schedule II controlled substance, all in violation of 21 U.S.C. § 841(a)(1).

FORFEITURE ALLEGATIONS 21 U.S.C. § 853

- 1. The above allegations are incorporated herein for the purpose of alleging Forfeiture.
- 2. In committing the offenses alleged in Counts 1 & 2 of this Indictment, the same being punishable by imprisonment for more than one year, **JAMELE WYDALE MUNDY** used and intended to use the below-described property to commit and to facilitate the commission of the said controlled substance violations, and the below-described property constitutes proceeds obtained directly and indirectly as a result of the commission of the aforesaid violations of 21 U.S.C. § 841(a)(1).

U.S. CURRENCY:

- a) \$67,315.00 in United States currency seized on May 16, 2023, in Scott County, KY.
- 3. By virtue of the commission of the felony offenses charged in this Indictment, any and all interest **JAMELE WYDALE MUNDY** has in the above-described property is vested in the United States and hereby forfeited to the United States pursuant to 21 U.S.C. § 853.

PENALTIES

COUNT 1:

Imprisonment for not less than 10 years nor more than Life imprisonment, a fine of not more than \$10,000,000, and not less than 5 years supervised release.

If prior serious drug felony or serious violent felony conviction:

Imprisonment for not less than 15 years nor more than Life imprisonment, a fine of not more than \$20,000,000, and not less than 10 years supervised release.

COUNT 2:

Imprisonment for not less than 5 years nor more than 40 years, a fine of not more than \$4,000,000, and not less than 4 years supervised release.

If prior serious drug felony or serious violent felony conviction:

Imprisonment for not less than 10 years nor more than Life imprisonment, a fine of not more than \$8,000,000, and not less than 8 years supervised release.

PLUS: Mandatory special assessment of \$100 per felony count.

PLUS: Restitution, if applicable.
