**UNITED STATES' OBJECTION TO THE MAGISTRATE'S  
DECEMBER 1, 2025, MEMORANDUM OPINION AND ORDER  
CONCERNING CASEY MORRIS'S RELEASE**

Casey Morris (“Morris”) and her co-defendants committed a serious offense involving a firearm that resulted in the death of Kristopher Lewis (“Lewis”), a witness and defendant in this Court. Morris knowingly allowed her then paramour, Desmond Bellomy (“Bellomy”) and other Hot Boyz members to use her car to surveil Lewis. When talking about his use of the car, Bellomy said to Morris via text: “*gotta* learn his schedule[,] need this money,”<sup>1</sup> meaning that, for the first-hand participants in this crime, surveillance was a critical piece of the murder plot. Without the surveillance, for which Morris allowed the Hot Boyz to use her vehicle,<sup>2</sup> the Hot Boyz could not have uncovered Lewis’s workplace and license plate number;<sup>3</sup> could not have learned his schedule, and, in turn, could not have lied in wait for at least an hour before Lewis’s arrival to work on the morning of September 29, 2023, gunning Lewis down upon his arrival and then fleeing the scene.<sup>4</sup>

Morris's absence from the murder scene and her failure to fire a weapon do not equate to lack of culpability or lack of danger. Indeed, Rollie Lamar ("Lamar") also absented himself from the murder scene and never pulled a trigger. More famously, Terry Nichols absented himself from Oklahoma City on April 19, 1995, and never personally detonated a bomb. However, just as Nichols provided means and assistance to Timothy McVeigh to prepare for the bombing, a critical role that facilitated the offense, Morris knowingly and intentionally provided the means for the Hot Boyz to prepare for Lewis's murder.

The evidence also points to a plan to use Morris's vehicle for the murder itself. However, having planted a Nokia C100 in her vehicle to track Bellomy's movements,<sup>5</sup> Morris caught Bellomy at the residence of another woman overnight on September 27, 2023.<sup>6</sup> Morris's text messages clearly indicate that she *only* withdrew consent to punish Bellomy for his infidelity, not out of some crisis of conscience. Morris never notified law enforcement of Lewis's impending doom<sup>7</sup>—even though her brother-in-law was a law enforcement officer to whom she frequently went for help and information. After the murder, Morris said that she wished she allowed Bellomy to use the car.<sup>8</sup>

Meanwhile, Morris’s history involves multiple instances of either being willing to obstruct justice<sup>9</sup> or actually taking steps to obstruct justice, including witness intimidation,<sup>10</sup> post-offense collusion,<sup>11</sup> the provision of false statements,<sup>12</sup> and obtaining information from her brother-in-law.<sup>13</sup> Morris also finds herself involved in two violent crimes: the July 2023 home invasion<sup>14</sup> of her former neighbors and Lewis’s murder.<sup>15</sup>

Because of her willingness to aid violent felonies and obstruct justice, Morris’s release poses a danger to the community, the witnesses in this case, and the integrity of this prosecution.

### **PROCEDURAL HISTORY AND SUPPLEMENTATION OF RECORD**<sup>16</sup>

Morris is charged with abetting/abetting and conspiracy to commit the murder-for-hire of Kristopher Lewis (“Lewis”) as well as conspiracy to use a firearm in a federal crime of violence. The United States moved for Morris’s detention under 18 U.S.C. §§ 3142(f)(1) and (f)(2).

At the detention hearing on November 24, 2025, United States Magistrate Judge Matthew Stinnett (“Magistrate Stinnett”) heard over an hour of testimony about Morris’s willingness to

obstruct justice for her friend and convicted murderer, Joshua Brown;<sup>17</sup> her false statements to Richmond Police Department (“RPD”) about a vehicle owned by her “cousin,” Shylah Lyvers (“Lyvers”), being stolen from Morris’s residence—the same vehicle used in a strong arm robbery perpetrated by Morris’s boyfriend, Desmond Bellomy (“Bellomy”), and Lyvers’ boyfriend, William Dixon (“Dixon”); Morris pumping her sister and brother-in-law for sensitive law enforcement information about the robbery; Morris’s knowing assistance to Bellomy and Dixon in the plot to murder Kristopher Lewis; Morris deleting information from her phone about the murder plot; Morris providing Bellomy with a false affidavit to aid his felon-in-possession-of-firearm case; and Morris passing messages between two other Hot Boyz members and co-defendants, helping them to get their story straight for court.

Because the United States believed testimony about some of these topics to be sufficient, and to limit the duration of a late-afternoon hearing, the United States did not introduce exhibits on each of these topics. Where the United States relied exclusively on testimony, Magistrate Stinnett appeared dissatisfied with the amount of proof. Because this Court reviews Magistrate Stinnett’s release order *de novo*, the United States has supplemented the record here.

In addition to supplementing proof on the matters above, the United States also adds additional information relating to Morris’s other past conduct and criminal activity, including her receipt of contraband for her friend and previously convicted drug offender, Justin Ison;<sup>18</sup> her

direction to an unknown person to “file the affidavit and drop the EPO;”<sup>19</sup> and her history of purchasing and/or allowing Bellomy, a convicted felon, to use firearms.<sup>20</sup>

### **FACTS OF THE CHARGED OFFENSES**<sup>21</sup>

The investigation conducted by Lexington Police Department (“LPD”) and FBI indicates that Lamar paid members of a violent street gang, the Hot Boyz, to murder Lewis to prevent his testimony in Lamar’s federal drug trafficking case.<sup>22</sup> Dixon, Daquis Sharp (“Sharp”), Jatiece Parks (“Parks”), and Bellomy carried out Lewis’s execution; Boone acted as a communication and payment intermediary between Lamar and the other Hot Boyz; Morris provided assistance to the Hot Boyz assailants by allowing them to use her vehicle for surveillance; and Quincino Waide, Jr. (“Waide”) helped the Hot Boyz assailants dump the murder vehicle.

On September 29, 2023, at approximately 8:15 AM, Lewis drove to his employment at Koch Air on Trade Street in Lexington.<sup>23</sup> When Lewis parked and exited his vehicle, three masked individuals exited a dark colored sedan and shot Lewis, killing him.<sup>24</sup> The dark-colored sedan (or “subject vehicle”) then fled the scene.<sup>25</sup>

According to witnesses, the subject vehicle had been sitting in the parking lot for a significant time before Lewis's arrival.<sup>26</sup>

A commercial truck that was sitting in the parking lot captured some of the incident on its in-cab camera.<sup>27</sup> The in-cab camera showed Lewis's vehicle enter the parking lot. The murder itself was not captured on video, but the camera captured the sound of the gunfire. The in-cab camera showed the subject vehicle leaving the scene immediately after the gunfire.

Based on witness statements, law enforcement queried Flock camera data for a black sedan operating in the early morning hours, locating a black Acura that Daquis Sharp was known to operate (hereafter, "Acura").<sup>28</sup> The Acura was the only vehicle matching the description of the subject vehicle that was active and captured by Flock on the morning of the shooting.<sup>29</sup>

Law enforcement collected multiple shell casings from the scene.<sup>30</sup> NIBIN testing on the shell casings further corroborated the Hot Boyz' involvement with .9mm and .40 caliber shell casings from the homicide scene matching two other shootings in which Sharp's black Acura was captured on video.<sup>31</sup>

Law enforcement confirmed that Sharp was still using the Acura in the days leading up to the homicide by comparing his cell-site location data with Flock data.<sup>32</sup> However, after the homicide, the Acura was found abandoned at 1101 Centre Parkway in Lexington.<sup>33</sup>

Law enforcement discovered the identities and roles of each defendant through cell-site location data, cell phone, and social media searches.<sup>34</sup>

Dixon's cell-site location data placed him in the same area of Louisville as Lamar three days before the homicide, on September 26, 2023.<sup>35</sup> After the apparent meeting between Dixon and Lamar, Dixon made plans with the other Hot Boyz.<sup>36</sup> At approximately 8:30 PM on September 26, 2023, Dixon texted Bellomy, stating: "[a]nswer the phone bitch, we got shit on da flow."<sup>37</sup>

Text messages between Dixon's girlfriend and Morris's then-friend, Lyvers, on September 27, 2023, at 1:43 PM, indicate that Bellomy asked Morris to buy him "another" gun, stating both "he asked me to get him another gun" and "getting another gun."<sup>38</sup>

At 5:37 PM on September 27, 2023, Morris received a text from Bellomy, stating: "quick serious question."<sup>39</sup>

At approximately 5:58 PM, Dixon sent Bellomy the following messages:

- Dixon: Lil [now-deceased Hot Boyz member Chance Gist] on his way we bou go get dat mu-fucka
- Dixon: Is it a go
- Dixon: I done got everybody ready<sup>40</sup>

At 6:01 PM, Bellomy responded to Dixon, stating "ya bet" and "she good wit it."<sup>41</sup>

Although it appears that one or two other females knew about the plot to murder Lewis, Morris is

the only female known by law enforcement to assist with the plot.<sup>42</sup> Based on Morris being the sole female abettor and her boyfriend (Bellomy) being the person to report “she good wit it,” law enforcement believes that “she” is Morris.

At 6:03 PM, Morris texted Bellomy and said: “...I don’t want it to just be sumn you doin for me.”<sup>43</sup> Bellomy responded: “its gonna be for the both of us...”<sup>44</sup> The content and timing of these messages and the “quick serious question” message, all found on Morris’s phone, further point to Morris being “she.”

On the evening of September 27, 2023, Dixon and the other Hot Boyz began surveilling Lewis.<sup>45</sup> Text messages indicate that Dixon and Bellomy had Morris’s vehicle that evening.<sup>46</sup> However, Morris planted a Nokia C100 smart phone in her vehicle to track Bellomy’s movements.<sup>47</sup> Overnight on September 27, 2023, Morris saw Bellomy’s location at his other girlfriend’s house,<sup>48</sup> prompting Morris to claim that she needed her car to go to the hospital.<sup>49</sup> Morris’s spat with Bellomy continued through September 28, 2023, generating the following text messages:

- Morris: I was omw to the hospital !!
- Morris: Are you on you way ?
- Bellomy: ok well im sorry & no I’m going back to sit in this house for rn
- Morris: Why
- Bellomy: gotta learn his schedule need this money
- [“!!” emphasis placed on “gotta learn his schedule need this money.”]

- Morris: I need my car
- Morris: But I don't expect you to care
- Morris: You've literally showed me time and time again that I don't mean shit to you
- Morris: Sitting in the house ain't gon learn nobody's schedule either
- ["Haha" emphasis placed on sitting in the house ain't gon learn nobody's schedule either"]<sup>50</sup>

These and other text messages show that the Hot Boyz had Morris's vehicle for their surveillance activities on September 28, 2023.<sup>51</sup> Corroborating these messages, Sharp and Parks captured a video of themselves in the backseat of Morris's car while on their way to conduct surveillance.<sup>52</sup> Law enforcement confirmed Sharp and Parks were in Morris's vehicle by comparing body worn camera footage from Morris's October 2023 car accident.<sup>53</sup>

Regarding Bellomy's claims that he "gotta learn his schedule need this money," Bellomy was not employed in September 2023 and was certainly not employed in any position that would require him to perform surveillance on an individual.<sup>54</sup> Notably, this was not the first time that Bellomy used Morris's car for illegal activities. On January 30, 2023, Morris told her friend Justin Ison ("Ison") that Bellomy could not return her car because the police were too hot.<sup>55</sup> On September 16, 2023, Bellomy told Morris that he would be going back to Lexington in her car because there might be some "money on the floor," which commonly refers to payment for illegal activity.<sup>56</sup>

Dixon's cell-site location data, which contained more detailed location information than many records available to law enforcement,<sup>57</sup> placed him in the precise area of Lewis's home and work on September 27-28, 2023.<sup>58</sup> When law enforcement searched Dixon's cell phone, they located a text from Dixon to several other Hot Boyz on September 28, 2023, that included Lewis's license plate number.<sup>59</sup> Dixon's cell-site location data shows him in the area of Lewis's workplace when the message was sent.<sup>60</sup> Lewis's timecard shows that he was at work when Dixon sent the message.<sup>61</sup>

Bellomy's cell-site location data also places him in the area of Lewis's home and work on September 27-28, 2023.<sup>62</sup> In addition to the cell-site location data, Morris, using the "find my device" service for the smartphone that she secretly placed in her car, took a screenshot of Bellomy's location, capturing Bellomy outside of Lewis's house on September 28, 2023, at 1:07 PM.<sup>63</sup>

After performing surveillance in Lexington on September 28, 2023, Bellomy returned to Morris's residence in Richmond that evening.<sup>64</sup> Still enraged about Bellomy staying at his girlfriend's house the night before, Morris decided to withdraw her consent for Bellomy to use the car, first having a romantic evening with him on overnight and then revoking her consent the following morning. At 8:13 PM, Morris texted Lyvers: "[h]e out there cleaning my car rn" and

“[h]e ain’t usin it no more cause Ik sumn he don’t know.”<sup>65</sup> Morris later added: “he ain’t takin my carrrr” and “[h]e need to find some material to build a bridge so he can get over it.”<sup>66</sup>

In the early morning of September 29, 2023, Morris described the evening to Lyvers, saying that she and Bellomy showered together and that he sweettalked her.<sup>67</sup> However, while Bellomy slept, Morris went through his phone and texted the other girlfriend.<sup>68</sup> Morris then described the moment that Bellomy realized there was an issue with the car, saying “I woke him up I said des I don’t think we needa do this anymore he turned over soo fast lol.”<sup>69</sup> Morris also said: “*they* can all miss meeeee I wasn’t in the wrong at all.”<sup>70</sup>

In addition to Bellomy staying with Morris in Richmond overnight, Sharp and Parks lived in Richmond.<sup>71</sup> FLOCK and cell-site location data indicate that Bellomy and Sharp’s Acura traveled from Richmond towards Dixon’s home in Lexington in the early morning hours.<sup>72</sup>

Dixon’s cell phone also revealed that, around 5:00 AM September 29, 2023, Bellomy, Dixon, and Sharp texted one another to coordinate picking each other up, also discussing the location of gloves and plates.<sup>73</sup> These messages occurred prior to the FLOCK hits in Lexington at 5:39 AM, 6:02 AM, and 6:06 AM.<sup>74</sup>

Consistent with eyewitness reports that the suspect vehicle had been at the Koch Air parking lot since approximately 7:00 AM, surveillance footage near the murder scene captured the Acura's arrival at Trade Street significantly before Lewis's arrival. Surveillance footage, in addition to the in-cab camera video, also captured the Acura's flight after the murder.<sup>75</sup>

After the homicide, in the late afternoon/early evening, Dixon and Lamar's cell-site location data shows them in the same area of Lexington.<sup>76</sup> Around that time, Dixon and Sharp texted each other to discuss payment to Waide and Boone, referencing payment to Boone and Waide "from the 4 of us."<sup>77</sup> Again, law enforcement believes that four Hot Boyz were present on Trade Street to murder Lewis—Sharp, Dixon, Bellomy, and Parks.

Shortly after the homicide, Dixon and Parks began posing with thousands of dollars in cash on social media.<sup>78</sup>

On September 30, 2023, Morris told Lyvers: "I wish I wouldn't said nun[,] low key[,] I wish I woulda gave em my car [and] let em come back [and] then me just take him back home and leave him on silent."<sup>79</sup>

Text messages from Morris's phone indicate that she and Bellomy were talking again by September 30, 2023.<sup>80</sup> Bellomy said: "yea they were mad at u but more mad at me bc I let the shit

happen.”<sup>81</sup> Morris responded: “[y]eah Ik trust me I’ve thought about it and I’ve felt bad but I was tore up.”<sup>82</sup> On October 1, 2023, Morris and Bellomy exchanged the following messages:

- Morris: Aye fr tho I feel like we had one of the best nights Thursday<sup>83</sup>
- Bellomy: who
- Bellomy: how
- Bellomy: you fucked it up along w my stupidity
- Morris: Yeah we both played a roll in that but I’m talkin bout the night not the morning now
- Morris: Yeah like i told you, you had me feelin like you really wanted me in your life and I needed that cause I had been questioning it for awhile .
- Morris: That’s really what I been tryna tell you tho . Spendin time together like that is important . Not you just comin to fuck shower n leave and occasionally stay the night .
- Bellomy: eh hh i been onna hustle<sup>84</sup>

A few days after the murder, Morris told another person via text that Bellomy was going to help her start a business.<sup>85</sup> Again, Bellomy was unemployed at the time.<sup>86</sup>

Text messages between Dixon and Deangalo Boone provide evidence of payment from Lamar to the Hot Boyz in the days and weeks after the murder.<sup>87</sup>

### **OTHER FACTS RELEVANT TO DETENTION**

As discussed in greater detail below, law enforcement executed a search warrant on Morris’s phone in May 2024. The search warrant sought information about Lewis’s homicide and a false affidavit from Morris relating to a firearm incident that was located on Morris’s phone.

While searching the phone for information about the firearm and homicide cases, law enforcement encountered information about other criminal activity.<sup>88</sup>

#### **A. Willingness to Provide Affidavit for Joshua Brown**

On October 27, 2015, Joshua Brown (“Brown”) murdered his girlfriend’s father and injured two other people with a firearm in Madison County, Kentucky.<sup>89</sup> Brown pleaded guilty to one count of murder as well as other charges. Madison Circuit Court sentenced Brown to thirty-five years imprisonment.<sup>90</sup>

In 2021, Brown communicated with Morris and Ison about Morris providing false testimony via affidavit to reduce Brown’s charge and his sentence.<sup>91</sup> Brown wanted Morris to state that he called Morris after the murder and described a physical altercation with the victim. Brown said that law enforcement could no longer subpoena phone records and therefore could not prove the claim was false. Morris’s responded to Brown: “I wanna write you that letter but I need more info.”<sup>92</sup>

When discussing the issue with Ison, Morris said that she researched the penalties for perjury in Kentucky and expressed concern that law enforcement already had the phone records.<sup>93</sup> She then told Ison: “*I wanna help that man any and every possible* but I can’t risk going to jail. If

I knew I had someone to take care of [my daughter] *I'd do it in a heart beat* but I gotta think about her.”<sup>94</sup>

While the United States does not know whether Morris ever signed this affidavit, she demonstrated a willingness to do so and, later, she followed through on providing an affidavit with false information for one of Bellomy’s criminal cases.

### **B. Assistance to Drug Trafficking**

Morris’s phone also contains conversations with Ison about drug trafficking. SA Robison testified that he was unsure whether Morris ever actually accepted delivery of the packages.<sup>95</sup> Morris’s phone data indicates that she did.

For example, in June 2022, Morris accepted a package containing drugs for Ison.<sup>96</sup> In July 2022, Ison texted Morris: “[c]an I have like 6k sent to your house ? It’s only money nothin illegal this time. I’ve had something seized at my house so I don’t even wanna risk it.”<sup>97</sup> Morris agreed.<sup>98</sup> In September 2022, Morris texted Ison: “I want some shmoney Dale . When we doing another drop off ?”<sup>99</sup> Morris received at least one package per month for Ison through July 2023.<sup>100</sup>

### **C. Home invasion**

On July 27, 2023, three masked and armed individuals entered a residence, tying up the adult residents and demanding money.<sup>101</sup> Surveillance video footage provided clear depictions of the masked individuals and the vehicle that they used—a blue Kia Optima.<sup>102</sup>

While investigating that robbery, RPD received a call for service from Lyvers relating to a stolen vehicle—a blue Kia Optima.<sup>103</sup> The call came from Morris’s residence.<sup>104</sup> Lyvers described to the responding officer, Officer Knight, where Lyvers parked the vehicle and how long it had been there.<sup>105</sup> Subsequent review of surveillance video revealed that the vehicle was never parked on the street where Lyvers advised it was.<sup>106</sup>

When law enforcement interviewed Morris, she claimed that Lyvers was her cousin.<sup>107</sup> She also claimed to not know Lyvers’ boyfriend.<sup>108</sup> When asked about the car, Morris first said that the car was parked on the near side of the mailboxes and that she noticed the car when Lyvers arrived.<sup>109</sup> Morris said that she noticed the car was missing when she left the apartment to get food.<sup>110</sup> After law enforcement confronted Morris with the evidence from the surveillance cameras, Morris’s story began to evolve. She first said that she thought that she saw the car, but she did not

step outside.<sup>111</sup> She then said that she assumed that Lyvers drove her car to the residence.<sup>112</sup> Eventually, Morris said that she did not personally see the car.<sup>113</sup>

On July 28, 2023, at approximately 11:00 PM, Dixon texted Morris's phone, saying: "[n]iggas need to get they wrap together tho" and "[p]olice is dumb hot."<sup>114</sup> In other words, according to Dixon, everyone needed to get their stories straight because law enforcement was being intense.

On July 29, 2023, at approximately 2:33 PM, someone whose messages had been deleted from Morris's phone texted Morris,<sup>115</sup> telling her to drive slow because "police is there."<sup>116</sup> Morris responded "Ik she just passed me in traffic."<sup>117</sup> The other person said: "who" and "the cop."<sup>118</sup> Morris responded "yeah." A female RPD officer interviewed both Lyvers and Morris about the stolen vehicle.

On July 29, 2023, Lyvers called LPD to report that she found her vehicle parked in Richmond.<sup>119</sup> Lyvers claimed that Morris drove her around to find the vehicle.<sup>120</sup> When LPD responded to Lyvers' residence, Lyvers' mother, who allegedly picked Lyvers up from Morris's

house after the vehicle was stolen,<sup>121</sup> said that Lyvers did not mention anything to her about her car being stolen.<sup>122</sup> RPD eventually impounded the vehicle as part of the robbery investigation.<sup>123</sup>

On July 30, 2023, at approximately 9:00 AM, Morris began asking her sister for information about the victims of the home invasion.<sup>124</sup> Morris said that she knew two people who lived at that location (the same two people who happened to be the adult victims of the home invasion).<sup>125</sup> Morris also volunteered that the male victim used to be a drug dealer.<sup>126</sup> Morris's sister responded that she would ask her husband, RPD Officer Kelvin Alexander ("Alexander"), about the identity of the victims.<sup>127</sup> At approximately 4:15 PM, Morris asked her sister if she asked her husband about the victims.<sup>128</sup> At approximately 6:07 PM, Morris told her sister that Alexander confirmed the identity of the victims.<sup>129</sup> Morris's sister then said that Alexander said that law enforcement suspected that the assailants robbed the victims "over drugs."<sup>130</sup> At approximately 6:55 PM, Morris's sister shared with Morris that Lyvers' vehicle was used in the robbery.<sup>131</sup>

RPD recently identified Dixon (Lyvers' boyfriend) and Bellomy (Morris's boyfriend), as two of the assailants in the home invasion.<sup>132</sup> Bellomy and Dixon were each identified on

surveillance footage through their physical description and unique clothing items, including a gold pair of sneakers.<sup>133</sup>

In addition to Morris's connection to Bellomy, Lyvers' vehicle purportedly being stolen from Morris's residence, Morris's false statements to RPD during their investigation of Lyvers' vehicle, Dixon texting Morris's phone about people getting their wrap together, Morris's post-offense discussions about avoiding a female cop, her queries about law enforcement's investigation, and her knowledge of the male victim being a drug dealer, Morris lived next door to the victims the year before the robbery.<sup>134</sup>

#### **D. Firearm Case**

On November 7, 2023, Kentucky State Police ("KSP") performed a stop on Dixon and Bellomy in Shelby County, Kentucky, discovering two firearms in the Cadillac sedan that Dixon and Bellomy had been driving.<sup>135</sup> The Commonwealth initially charged the case, and the United States later brought federal charges.

On the day of this incident, Morris texted her brother-in-law about the incident, changing the identities of the individuals involved and asking whether a third party claiming ownership of a gun would cause felon-in-possession charges to be dropped.<sup>136</sup> Morris also texted Dixon, stating: "he needs to say he had no idea it was in the car" because "[i]t's gunna make a better case for him."<sup>137</sup>

Evidence from Dixon's phone and Morris's phone indicate that Morris drafted and notarized an affidavit claiming that she owned the guns and left them in the Cadillac when a driver of the Cadillac dropped Morris off to pick up a rental vehicle.<sup>138</sup> Although the affidavit is not visible on Kentucky Courtnet, the undersigned recently confirmed that Bellomy's defense attorney notified the Commonwealth of the affidavit as well as Bellomy's intention to call Morris as a witness.<sup>139</sup>

When interviewed by law enforcement in May 2024, Morris repeated the story about leaving two firearms in the Cadillac while picking up her rental vehicle.<sup>140</sup> Although Morris claimed that she left two firearms in the Cadillac, she said that she did not recognize one of the firearms and the drum magazine on the other firearm that KSP located in the Cadillac.<sup>141</sup>

Morris's affidavit and intended testimony was false. Morris wrecked her vehicle on October 5, 2023, and picked up her rental vehicle on October 6, 2023.<sup>142</sup> Morris kept the same rental vehicle until November 20, 2023.<sup>143</sup> Dixon's mother bought the Cadillac on October 9, 2023.<sup>144</sup> Dixon and his family therefore did not own or possess the Cadillac when Morris obtained her rental car.

Moreover, Morris's text messages with Dixon and others clearly indicate that she provided the affidavit as a favor for Bellomy. Morris sent one such message to her friend in February 27, 2024, saying: "then I'll contact his lawyer and tell him take my letter n shred it cause I'm not

helping him.”<sup>145</sup> She also texted Dixon, saying: “[i]f Desmond don’t bring me my car back I’m not helping with the court situation” and “[h]e can’t respect me and my shit I can’t help him.”<sup>146</sup>

### **E. Encounter with FBI and Deletion of Messages from Phone**

As noted above, on May 21, 2024, FBI and LPD interviewed Morris about the firearm case and Lewis’s homicide. Following that interview, Morris called Bellomy at Pulaski County Detention Center and told him about the interview.<sup>147</sup> Bellomy cryptically told Morris to destroy evidence on her phone.<sup>148</sup> After hearing that call, law enforcement returned to Morris’s residence and seized the phone.<sup>149</sup> When law enforcement searched the phone, they learned that Morris deleted her text conversation with Bellomy.<sup>150</sup> She also deleted her text conversations with Lyvers and Dixon.<sup>151</sup> Those conversations no longer exist in their entirety, and the few remaining messages have limited metadata.

Although Morris told law enforcement that she did not know Bellomy’s friends, including their names,<sup>152</sup> Morris also texted Dixon’s mother about her interview with law enforcement.<sup>153</sup> Dixon’s mother said: “I hope you didn’t say anything over that phone with him!!! Those calls are

recorded and I don't want you saying anything to incriminate you him or anyone else.”<sup>154</sup> Morris responded: “No all I told him was who came and that was all[;] he wants me to call him lawyer and talk to him.”<sup>155</sup> Morris and Dixon's mother then made plans to meet in person.<sup>156</sup>

#### **F. Association with Nasheim Dixon and Stephan Fisher**

Morris has maintained contact with other Hot Boyz members or associates in recent months, namely Nasheim Dixon (“Nasheim”) and Stephan Fisher (“Fisher”), both of whom are related to Dixon and Bellomy.<sup>157</sup> After law enforcement apprehended Nasheim and Fisher for using stolen credit cards (among other things), Morris passed messages between Nasheim and Fisher so that they could get their stories straight.<sup>158</sup>

#### **G. Login to Fayette County Detention Center**

At Morris's detention hearing, the Court provided Morris with an admonishment to avoid direct or indirect contact with “any person who is or may be a victim or witness in the investigation or prosecution of this matter,” noting:

Obviously, this condition is the one that gives me a lot of concerns here, Ms. Morris. I can't list off every individual possible from Mr. Ison to Mr. Fisher or anyone else; I can just list off the co-defendants. But rest assured that if there is a violation relevant to this condition, your release will be removed, and you will be detained.

*See* R. 160: Court, TR (Detention Hearing) at 1069. Following Morris's release from custody on November 24, 2025, she logged into Fayette County Detention Center's communication platform from her laptop on November 28, 2025, to read a message from Nasheim.<sup>159</sup> It is unclear whether

her third-party custodian knew about this activity. Although Morris did not obstruct justice on this occasion, her login demonstrates that the ease with which she can communicate with individuals who are connected to the other defendants in this case without any monitoring or detection from the United States Probation Office.

This login also demonstrates Morris's difficulty staying away from her past associates. After the Court's admonishment above, most reasonable people would have steered clear of communicating, even passively, with individuals who were mentioned during the hearing. Yet, it only took Morris four days to surrender to temptation.

Similarly, although Morris's former attorney advised her to stop talking to Bellomy in 2024,<sup>160</sup> she remained unable to do so.<sup>161</sup>

### **CONCLUSION**

The United States believes that Morris's detention is appropriate under both 18 U.S.C. §§ 3142(f)(1) and (f)(2).

Morris's lack of criminal history fails to equate to lack of criminal activity. Morris has a history of aiding criminal activity (e.g., her receipt of deliveries for Ison and her involvement in the home invasion), and this poor judgement escalated to her aiding Lewis's murder in 2023.

Morris has also continuously maintained an association with Bellomy and other Hot Boyz, despite knowing about their criminal conduct and despite those associations having personal cost to her.<sup>162</sup>

Moreover, Morris has a troubling history of either being willing to obstruct justice or actually obstructing justice. Morris told a convicted murderer that she wanted to write a false affidavit for him but needed more information; attempted to pressure someone to drop an EPO and file an affidavit; provided false statements to RPD; pumped her brother-in-law for information about the home invasion; provided a false affidavit in Bellomy's firearm case; provided false statements to FBI and LPD about the firearm case and her knowledge of Bellomy's friends; deleted evidence from her phone; and helped two co-defendants get their story straight.

Morris engaged in many of the activities listed above using her phone and could easily engage in most of that conduct with any communication device. As noted above, Morris has already communicated with Dixon's mother, who is not in custody, about this case. It is unclear how a third-party custodian, particularly one who is not home with Morris 24/7, can ensure that she is not communicating with people who could pass messages to witnesses or co-defendants.

Meanwhile, “[p]retrial Services lacks the resources and technology to ensure a defendant released to home confinement cannot and has not accessed any internet-capable device.” *United States v. Dhavale*, No. 19-mj-00092, 2020 U.S. Dist. LEXIS 69800, at \*13 (D.D.C. Apr. 21, 2020). Even when a defendant is released on “the most restrictive conditions possible,” there is “no way” the court can prevent the defendant or others acting on the defendant's behalf from contacting witnesses. *United States v. Clemon*, No. 3:21-CR-30003-DWD-4, 2022 U.S. Dist. LEXIS 125140, at \*22-23 (S.D. Ill. July 14, 2022).

“[C]ourts have concluded that even non-violent threats to the judicial process may constitute a sufficient danger in the BRA context.” *United States v. Comberger*, No. 5:21-mj-05138-MAS-1, 2021 U.S. Dist. LEXIS 83204, at \*14-15 (E.D. Ky. Apr. 29, 2021). “Even a single

incident of witness tampering has been a ‘traditional ground for pretrial detention by the courts.’”  
*United States v. Epstein*, 425 F. Supp. 3d 306, 318 (S.D.N.Y. 2019).

Morris has engaged in obstructive conduct relating to this investigation and others. The circumstances that made it possible for Morris to engage in obstructive conduct—namely, her access to communication devices—have not changed. Because the Court cannot prevent Morris from contacting witnesses or indirectly colluding with co-defendants, the United States objects to her release.

Morris’s inclination towards collusion combined with the other defendants’ family members facilitating three-way calls or otherwise passing information between suspects creates a particular danger.<sup>163</sup>

Regardless of whether the United States’ burden is “clear and convincing” or something less, the United States believes that it has proven Morris’s extraordinary disregard for the investigative and judicial process, one that is likely to repeat itself given the lack of changed circumstances. This proof includes not just a single incident of obstructive conduct, but a pattern; and not just a single incident of engaging in criminal activity or associating with those who have engaged in criminal activity, but a pattern. If Morris cannot be detained pursuant to 18 U.S.C. § 3142(f)(2)(B), it is difficult to imagine any “non-violent” defendant who can.

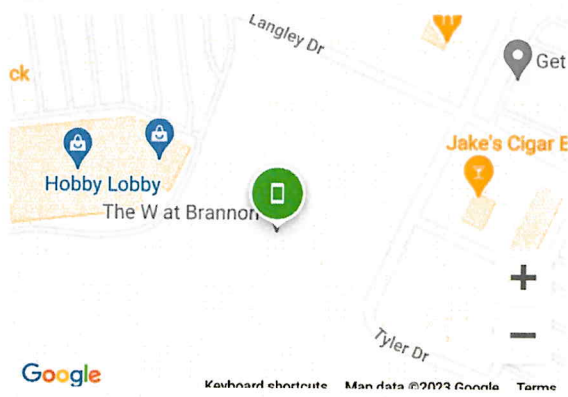

I got now.

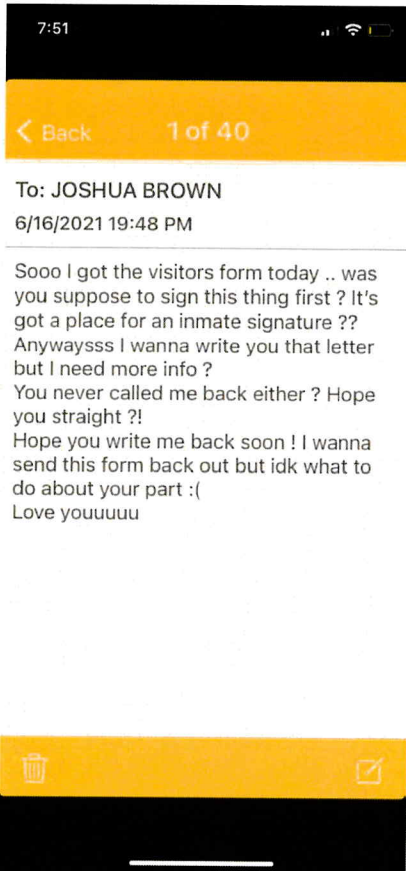
To be on the safe side I cant talk


